Title 5 CCR §11969 specifies that a requesting charter school must determine a reasonable projection of the in-district average daily classroom attendance (ADA) for the applying school year.

The ADA projections provided above are based on our observed ADA during the 2015-2016 and 2016-2017 schools years, and as modified to account for our anticipated growth during the 2017-2018 school year. The The average yearly retention rate for COVA is approximately 88%. Empty seats are filled from the waiting list. The Charter School projects maximum class size student enrollment per grade level with K-22 students, 1^{st} - 3^{rd} – 24 students, and 4^{th} - 8^{th} – 30 students to develop its ADA projections for 2017-2018.

COVA has maintained an average of 150-200 students on the waiting list for the last 3 years, and receives over 400 applications throughout the school year. Due to lack of classroom space, we are currently at maximum enrollment for our facility and not able to accept every applicant. Our 5 year plan, provides for annual growth to a maximum of 450 students. With an appropriate facility for the 2017-2018 school year, we would be able to accommodate additional students up to our projected maximum. COVA continues to recruit students from underserved populations through outreach to churches, community concerts, neighborhood festivals and fairs.

COVA's currently has 155 students that reside in Oakland. Based on previous intent to return forms that COVA sends out, we anticipate that all 155 will be returning.

We wish to be located in the North Oakland or Central Oakland area that is accessible to public transportation. COVA is a performing arts schools that need rehearsal and performance space. There are schools located where COVA may rent space such as the Grand Lake Theater across from Lakeview Elementary. Possible school sites are: Lakeview Elementary, Claremont Middle School, King Estates Middle School, Howard Elementary, Tilden Elementary or any similar schools that have performing facilities.

COVA (K-8) is a music conservatory program which has needs besides traditional classrooms and office space. Our music program requires dedicated rehearsal spaces as well as spaces for instruments and equipment that cannot be broken down on a daily basis. In addition, we need an auditorium and storage areas for large musical instruments. We also need space appropriate for our growth plan of 450 students in grades K-8 with a current minimum of 18 classrooms to serve 240 students for the 2017-2018 school year.
