In the spirit of Superintendent Wilson's District-Charter Compact, the Office of Charter Schools has scheduled two more working groups at our office during the first week of February.

On **Tuesday, February 3rd from 3:30-5pm** we'll meet to discuss our draft of the OUSD Framework for Effective Teaching. Ultimately, OCS will apply this framework in our classroom observations at your schools.

We'll meet on **Thursday, February 5th from 3:30-5pm** to cover the draft of Collective MPOs that we will be asking our charters to move towards. Some of the main issues left to explore include, high school MPOs and criteria for determining whether annual MPOs have or have not been met.

We highly encourage you to engage in our working groups. Charter leader participation is critical to producing strong and comprehensive drafts that incorporate the various focus areas of all of our schools.
